President's Report Con't

• Zone Business

- We needed to make some quick decision last month regarding jackets and equipment, thank you to everyone who responded. President solicited feedback on the process.
- The executive agreed to continue using this format but only on exception basis
- Neil's email explanation as a reference document:

We have more than sufficient funds to pay for this order. We are about to receive a ski sale cheque for \$90,000 - \$30,000 more than our budget for this revenue category. If we were to pay for these jackets now we would still have a favourable net of revenues vs expenses. But, I don't believe we will pay for the jackets up front so the bill won't need to be paid until they arrive. Really what is being asked is can the LL patrol add \$12,500 to next year's budget. Therefore this really isn't an issue for the current budget but it will pre approve an item for next year. We had \$7,000 budgeted for uniforms this year and we have spent all of that by creating a pack inventory.

We have a pretty good inventory of Helly Hansen jackets that the other patrols use so it is unlikely we will need to buy more of those.

We have a regular line in the budget for uniforms (jackets and packs) so these are standard items we purchase on a regular basis and are items that are a high priority for our operations not a special purchase or item we would not normally approve as part of our budget.

Finally, these jackets need to be ordered now before we prepare our budget for next year.

Bottom line - I have no objections and would advise that this purchase should not cause any issues with this year's budget or next year's.

 night at dinner with Mike Palamarek & Marty, we spoke of things that are impactful to the Division &

 - The National Management Team must engage the membership in future directions, without engagement the initiatives will wither and die.
 - Culture and Communication was a big part of our discussion, these are very broad topics, but they
 work hand in hand, communication, I have an open line and was asked to call Bruce with issues, I
 also informed Bruce that communication is a two-way exchange and he should be reaching out to
 the ZP's. Old Guard, misogyny, resistant to change, we will not become relevant by adding more
 requirements on the membership. Let's figure out who we are and what we offer to our
 Customer.
 - Federated Charity model vs a Command and Control model, we are a Federated charity and have recently seen more of a command and control management style, we must return to our federated model with communication amongst all levels of the organization.
